Tuition and Fees 2016-2017

NEW STUDENT REGISTRATION FEE: \$100.00

The registration fee is only refundable if a student is denied admission. This fee covers the costs of processing a new student including screening, interviewing, billing, and records. This fee is due before processing can take place. **Students registering at NMBCS for the first time must present a Social Security Card, Birth Certificate and South Carolina Certificate of Immunization or waiver at the time of registration.**

RETURNING STUDENT REGISTRATION FEE: \$75.00

This non-refundable fee must accompany each student's application to NMBCS. This fee covers the costs associated with the application process. This fee will not exceed \$200.00 per family.

STUDENT RESOURCE/FACILITY FEE:

Resource Fee must be paid at the time of enrollment.

\$350.00 PER STUDENT FOR GRADES K3-K4
\$450.00 PER STUDENT FOR GRADES K-5
\$550.00 PER STUDENT FOR GRADES 6-12

All students will need to remit payment at the time of acceptance. This fee covers textbooks, classroom teaching supplements, technology support, library upgrades, student insurance, facility upgrades, lab fees, Stanford Testing fees, and student association dues. Additional fees for activities and purchases such as piano lessons, guitar lessons, yearbook, classroom novels, field trips, sports fees, and graduation fees are not included in this fee.

TUITION RATES:

\$3,670.00 FULL TUITION FOR GRADES K3-K4
\$3,970.00 FULL TUITION FOR GRADES K-5
\$4,170.00 FULL TUITION FOR GRADES 6-12

Tuition may be paid in full at any time or paid monthly over a 10 or 12 month period. Monthly payments are due the 1st or 10th day of every month and begin on June 1 or August 1. Due date is chosen at SMART TUITION set up. Tuition must be paid on or before the 10th day of each month. A substantial late fee of \$55 will be charged by SMART TUITION for payments received after the due date. Tuition is non-refundable if the student was present any day during the month. It is policy to suspend students due to non-payment whose account is 45 days in arrears.

SMART TUITION FEE: \$50.00 PER FAMILY

This Fee only applies to Families that choose the payment plan option. The payments will be made through the SMART TUITION payment service. The fee will be paid directly to smart tuition at the time of setup. This fee does not apply for families that pay in full.

DISCOUNTS:

- A discount of \$300 is given for a second child; a discount of \$600 is given for a third child. Resource & Registration fees only for fourth plus child.
- A discount of 10% is given for tuition paid in full at enrollment.

WITHDRAWAL FEE: \$500.00 PER STUDENT ALL GRADES

You are enrolling your child for the entire year, therefore budgets and teacher salaries are set accordingly. The early withdrawal of a student will create an opening which NMBCS may not be able to fill. Students who withdraw at anytime and for any reason between August 1, 2016 and June 1, 2017 will be assessed a \$500.00 withdrawal fee. For students who have paid in full, the withdrawal fee is waived, but no refund will be given. Official transcripts, report cards, and records will not be released or sent to other schools if there is any outstanding balance including the withdrawal fee remaining at North Myrtle Beach Christian School.

Doctrinal Statement

The following statement, based on the historical Christian view that the Scriptures are inspired by God and without error in the original writings, is the basic doctrinal position on which North Myrtle Beach Christian School operates. Faculty members and administrators, while free to interpret Scriptures on secondary doctrine with diverging views, must share a common acceptance of this basic statement of faith.

1. The Bible is the inspired word of God, the written record of His supernatural revelation, final in its content, and without any errors in its teachings.
2. All men in their natural state are lost, alienated from God, spiritually dead; “All have sinned and fall short of the glory of God” (**Romans 3:23**),
3. Salvation is only by grace, a free gift of God, through faith in the Lord Jesus, who died for our sins according to the Scriptures (**I Cor. 15:3**). Those who thus receive Christ by faith have their sins forgiven (**Eph. 1:7**), their hearts cleansed (**Acts 15:9**), are born of the spirit, become children of God (**John 1:12, 13**), are made new creatures in Christ (**II Cor. 5:7**).
4. God is one God, who reveals Himself in three Persons: Father, Son and Holy Spirit. Jesus Christ, as the Scriptures affirm, is the Son of God and Son of man, was born of a virgin, and is himself God. The Scriptures also declare the deity and personality of the Holy Spirit.
5. Our Lord Jesus rose from the dead in the same body that was laid in the tomb. (**John 20:25-27**). The bodies of all believers will be raised from the dead, and they will receive an incorruptible body like unto His glorious body (**I Cor. 15:23; Phil. 3:21**). All other men shall be raised unto “the resurrection of judgment” (**John 5:28, 29**).
6. Christians, born of the Spirit, are to live the new life in the present power of the Spirit. “If we live by the Spirit let us also walk” (**Gal. 5:16-25; Col. 2:6**). The Christian’s responsibility and his normal attitude of life is yield himself to God (**Rom. 6:13**), trusting God to keep him.
7. Christian “living” includes Christian service, showing the love of Christ to those around us, and the preaching of the Gospel in the uttermost parts of the earth. In carrying on this work there is needed the supernatural power of the Holy Spirit, which is granted to every believer as he yields and trusts (**Acts 1:8; I Cor. 12:7; Eph. 6:18, 19**).
8. Jesus Christ will come again to earth the second time (**Heb. 9:28**), personally (**Acts 1:11; Col. 2:9**) and visibly (**Matt. 26:64; Rev. 1:7**).
